Building Fees



July 2024

Fees payable for applications and permits relating to the *Building Act 2011* are set by legislation, being the *Building Regulations 2012* for the application fee, *Building Services Regulations 2011* for the Building Levy, and the *Building and Construction Industry Training Fund and Levy Collection Act 1990* for the CTF Levy Fee.

Estimated value of construction

The estimated value is defined in the *Building Regulations 2012*, Schedule 1:

- Contract value where the value includes the **relevant components** all goods including manufactured goods; labour; services necessary; fees payable; overheads; profit margin; or
- Other than under a contract i.e. owner/builder, the sum of the value (including GST) of the **relevant components** mentioned above.

If the fees relating to an application are not considered appropriate, then the estimated value of work may be determined by the local authority.
