## **DEVELOPMENT ASSESSMENT REPORTING PROCEDURE**

## **Assessment of Development Applications (DAs)**

For the purposes of this procedure there are three types of development applications:

#### Level 1

DA not advertised

## Level 2

DA is advertised; and

- No submissions; or
- Submission received but meets one of the following:
  - Not related to the reason the DA was advertised.
  - o The development is modified to comply or to remove the element of concern to the submitter.
  - o Submission is either of support, conditional support or is 'indifferent'; or is from a non-affected person.

### Level 3

A submission in opposition is received from an 'affected' person or special interest group in relation to the reason the DA is advertised or the development application is recommended for refusal.

**Note:** This procedure applies to development applications only. It does not apply to structure plans, scheme amendments or other types of planning proposals.
